**RESOLUTION AUTHORIZING TAX RESALE**



Taxes for the present year are to be paid by grantee(s) herein.

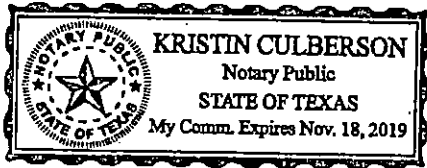
