KNOW ALL MEN BY THESE PRESENTS:

The undersigned, East Texas Poultry Supply, hereinafter referred to as First Party, enters into an agreement with Upshur County Commissioner of Precinct No. Z, Upshur County, and in order to get material to market it is necessary to use a portion of Upshur County roads located in Precinct No. Z over which Commissioner has jurisdiction and obligation to maintain in good repair, and both parties being aware of possible damage to said roads as a result of hauling on and over same, enter into the following agreement:

First Party agrees to use only that section of (described exact route, direction and miles in tenths)

8/10 mile on Periwinkle off Hwy 155, 3/10 mile Iris, 5/10 mile on Orchid

First Party agrees to use its vehicles in such a manner as not to block or interfere with other traffic on said road, so that said road will be open to travel by the public at all times.

First Party agrees to grade, maintain and otherwise repair said road, using its own equipment, labor and materials, if any needed, during the duration of time that First Party is bring in chicken house from lands location in Precinct No. Z, Upshur County.


