WHEREAS, the office of County Auditor for Upshur County, Texas, has heretofore been established in conformity with law, it is the duty of the District Judge having jurisdiction in Upshur County, Texas to appoint a County auditor; and

WHEREAS, the compensation of the County Auditor for Upshur County, Texas, has heretofore been set by law.

NOW, therefore, I Dean Fowler, Judge of the 115th Judicial District Court, the Court having jurisdiction in Upshur County, Texas do hereby appoint CONNIE WILLIAMS, a qualified person, as County Auditor of Upshur County, Texas; and she shall before entering upon the duties of said office take and subscribe the oaths prescribed by law, as set forth in Section 84.007 Texas local Government Code, and enter into a bond as therein provided, payable and conditioned as prescribed by law, and upon qualifying, shall hold said office and discharge the duties thereof from January 1, 2019 until December 31, 2020.

In accordance with Section 152.905 Texas Local Government Code, a public hearing was held regarding the salaries for the Upshur County Auditor and Assistant Auditors. After all parties in interest and the public had the opportunity to be heard the salary of the Upshur County Auditor's salary was set and is HEREBY ORDERED to be set at \$56,200.00 and the Assistant Auditors' salaries were set and are HEREBY ORDERED to be set at \$34,200.00.

This order shall be entered in the minutes of the 115th District Court of Upshur County, Texas, and be certified by the Clerk of said Court to the Commissioners' Court of Upshur County, Texas, which shall cause the same to be entered in the minutes with the appropriate order directing payment of the salaries.
