RE-OPENING OF ALL COUNTY OFFICES AND BUILDINGS


**WHEREAS**, on March 23, 2020 the Upshur County Commissioners Court ordered that all Upshur County offices, buildings, departments and facilities to close to the general public beginning at 12:00 noon Monday through Friday of each week; and

**WHEREAS**, upon deliberation and vote of the Upshur County Commissioners Court held in open session on May 15, 2020 it was determined by the Upshur County Commissioners Court that all public offices should reopen fully on Monday through Fridays of each week and directed the undersigned to rescind Directive No. 4 limiting the hours that county offices were to be open.

**IT IS, THEREFORE RESOLVED, ORDERED and DIRECTED** that all Upshur County offices, buildings, departments and facilities shall be and they are hereby ordered to re-open fully to the general public on Monday through Fridays of each week beginning Friday May 15, 2020 at 12:00 noon.


