A regular meeting of the Commissioners' Court of Upshur County, Texas was held on Wednesday, January 31, 2024 at 10:00 a.m., with the following members of the Court being present, to-wit:

Judge Tefteller called the meeting to order at 10:00 a.m.

1. Invocation and Pledges

Prayer was led by Gene Dolle.

Pledges to the U.S. & Texas flags led by Dustin Nicholson.

2. Consider and take action on approval of:

- A. The minutes of the previous meetings;
- B. Payroll changes;
- C. Payroll;
- D. Budget amendments;
- E. Accounts Payable;
- F. Accept for Recording: Auditor reports; Treasurer reports; Bonds; Oaths; Deputations; Certificates; State and County Taxes Summary; refund of overpayment or erroneous tax payments in excess of \$2500.00; and, applications for use of Upshur County roads and rights-of way and permit requests.

Motion by Dustin Nicholson with a second by Gene Dolle to approve items A-F. Motion carried 5-0. Unanimous vote in favor. (SEE ATTACHED)

3. Discuss and take action to accept for recording the correction plat for Settles Stomp subdivision.

Motion by Gene Dolle with a second by Dustin Nicholson to approve the Resolution (#2024-02) for Grant Application #2912107 for the Upshur County Victim Services Project for the 2024-2025 grant year. Motion carried 5-0. Unanimous vote in favor.

13. Discuss and take action on proposed changes to the existing interlocal agreements between Upshur County and Local School Districts regarding the Assessment and Collection of School Taxes.

14. Discuss and take action to accept notices from Big Sandy ISD, Union Grove ISD and Harmony ISD that the interlocal agreements in existence for the collection of school taxes is cancelled.

Judge Tefteller stated into the record that currently Upshur County is under interlocal agreements with all three school districts dated 1991. He further stated that the current interlocal agreements say Upshur County will collect the school districts' taxes and the County will select the law firm to collect those taxes. He further stated that those current agreements further say Upshur County is to pay the actual cost of collections at \$1.00 per tract cap. He stated that when the Upshur County Tax Assessor was going through her records, she proposed to update the interlocal agreements in 2023. Three districts sent back counter proposals indicating that they wanted to get to pick their lawyers for collection of taxes. Judge Tefteller also stated there was then discussion after discussion that Upshur County was cancelling those interlocal agreements.

Court recessed due to technical difficulties with the audio recording device. Mike Ashley was absent after recessing.

Court reconvened at 12:42 p.m. to continue discussion. Connie Williams, Upshur County Auditor, expressed concerns regarding the additional costs with the ACT software and that the County does not have the budget to pay these additional costs should the three school districts not pay these additional costs.

Judge Tefteller presented a new proposed interlocal agreement to the Court. Jay W. Miller made a motion with a second by Dustin Nicholson to cancel the existing interlocal agreement for the collection of taxes dated 1991 conditioned upon those three school districts, i.e., Harmony, Union Grove, and Big Sandy signing a new interlocal agreement wherein they agree to reimburse Upshur County the costs of collection. Motion carried 4-0. Unanimous vote in favor.

15. Hear any updates and discuss and take necessary action concerning the Round XII Courthouse Grant Renovation and/or the Courthouse employee relocation during the renovation.

Dustin Nicholson announced that he had spoken with Judge Leward LeFleur and that an abatement company has been selected to get rid of the asbestos. He also announced that law library books, pews, and jury chairs are being removed.
